



#### Sweeps Update...



The 2014 show season has come to an end and reports for the final three shows have now been received. Special thanks to the show secretaries who helped expedite the sweeps process this second half of the year by sending in point reports already calculated on the forms provided on the LRBA website. I appreciate your help tremendously as time is always in short supply.

As we enter a new show season, there as several things I would like to mention or highlight to make things easier for the next sweeps chairperson and also just as reminders of upcoming dates.... For those of you who have or will consider volunteering to be show secretaries in the future, the Sweepstakes Show Report can be found on the LRBA website under the forms section or by following this link:

http://www.louisianarabbits.com/uploads /1/0/8/2/10820662/2014\_sweepstakes\_f orm.pdf. It is available in both pdf and excel formats. After sending reports to the national breeds clubs, it is asked that you calculate the points, using the Specialty Club Points

Reports/Placement Reports and prepare the Sweeps Show Report for each show held, which again can be found on the LRBA website, given above, and forward that to the sweeps chairperson. (Since the Grand Champion Software does not calculate points correctly for Mini Rex, sending show reports for that breed is helpful if you have any question on how to figure the points correctly.) In doing so, it helps to speed up the

process of getting the sweeps board updated during the busy show season. It also removes the burden of printing reams of reports from being placed on one person when printing cost are not allocated. Again, big thanks to Sheila Spillers and Collette Waters who helped out this past show season in getting them to me that way. And remember, everyone wants their sweeps information as soon as possible, if secretaries will follow proper procedure, the people who paid to come to your show can get that information that much quicker. With the approach of the Annual State Show in March you may want to keep these things in mind in reference to sweeps... Section 3.

To qualify for sweepstakes and quality points, the exhibitor (i.e. individual, partnership, or combined rabbitry) must: A. Be a member of the LRBA, Inc. at the time of or join during the Annual State Show and must renew within thirty (30) days of expiration.

- B. Exhibit his/her breed(s) at any LRBA sanctioned show.
- C. Open Exhibit his/her breed(s) at any LRBA sanctioned show held during the sweepstakes year. Double points shall be awarded to any exhibitor that participates with his/her breed at the LRBA State show.
- D. Youth Exhibit his/her breed(s) at any LRBA sanctioned show during the sweepstakes year. Double points shall be awarded to any exhibitor that participates with his/her breed at the LRBA State show and/or the LRBA Youth Scholarship Show. Section 5.

Out-of-state exhibitors must be LRBA, Inc. members and also belong to a Louisiana local affiliated club throughout the sweepstakes and quality point year to accumulate sweepstakes and quality points. He/She must comply with qualifications set forth under Section 3 and 4 above.

I hope to have the last several shows (5) youth shows, 4 opens from AARC, CLRBA and Youth Scholarship Shows) that I recently received calculated and sweeps board then updated and sent to Colette by the end of this month (January). Then at that time, those placing 1st in each breed will be contacted to determine if they would prefer to receive a pin or a patch. Good luck to each of you in the upcoming show season. Remember to renew your membership within 30 days of expiration in order to remain eligible for sweeps. New members who would like to compete in sweeps must join by the Annual State Show in March. Don't forget the State Show in March counts double in sweeps points.

#### A WORD FROM THE Co\*Op

#### **Handling Success**

Many of us all came from a laid back rural lifestyle and exhibiting livestock is a way of enjoying our competitive spirit, while experiencing fun and fellowship with friends.

With enough hard work and some luck, some are able to become successful not only in the barn, but in the show arena as well. Once success has been reached, it is up to you as to how you can handle it. Will you be proud yet humble, or will you let success go to your head and quickly ruin the friendships that you have made and so dearly treasured since entering this venture? I have seen so many times where success has crumbled relationships. Remember if you are on top, you may have just bumped someone from being there; and sometimes this can be a problem. What you believed to be a strong relationship was crumbled by jealousy over a "RABBIT"! I have seen adults stand behind a youth and say "Well... he did it with a bought rabbit but can he breed his own?", only because their child's rabbit just got beat. I have seen a director of a national breed club not congratulate a youth only because the child that they were mentoring is no longer at the top because of new competition. I have heard snide comments about the price people must have paid for said rabbits, without knowing facts, comments based only on assumptions and made only because of discontent with how their own stock fared when competing against new stock. People are conditioned to believe that being on top makes them happy, but forget about what is really important, this being each other.

Below are a few things I feel should be important guidelines we should follow in order to maintain a confident and respectful attitude among fellow breeders and exhibitors.

- We all must remember that success is temporary, it takes lots of work to remain successful and compliancy is a direct tie to failure.
- Competition helps raise the bar on overall quality; welcome it with open arms and not a cold shoulder. In the long run, we will be much farther ahead when faced with quality show competition at the local level, regardless of whether that stock was purchased or homegrown. We all want to raise stock that can compete at a national level and having quality competition locally, helps assure us to get where we need to be nationally.
- Never forget what it took to get where you are and who helped you along the

- way, if not they may be the very ones you pass on the way back down.
- It takes a lot to keep animals in quality condition; it also takes a lot to breed top animals. If a breeder is kind enough to share their prize animals, be humble enough to share that special win and give due credit.
- Don't be short-sighted. Encourage others and be willing to listen, new insight on things will only help make you stronger in the long run.
- Help others, it's been said that when you can help others who cannot possibly help you in return, you have learned humility. But remember that volunteering/helping is not about you, it's about the people you have helped...so don't boast about what you have done. Your rewards should come from within.
- Never stop growing. Know your limitations and don't be afraid to admit them. Being willing to listen and learn is a huge part in remaining humble.
- There is a big difference between enjoying your wins and bragging.
   Bragging can degrade all the hard work you put into reaching your success, but worse than that it can destroy the dignity of fellow competitors and shows a lack of respect of others.

#### Proposal #1:

As stated:

Section 2: Internal Audit Committee - The Vice President along with three non-elected general members appointed by the President and Executive Board shall comprise the Internal Audit Committee.

- Publish results of Annual audit in the newsletter immediately prior to the Annual meeting and present said report at the Annual General Membership meeting.

Proposed change:

Section 2: Internal Audit Committee - The Vice President along with three non-elected general members appointed by the President and Executive Board shall comprise the Internal Audit Committee.

- A. The Internal Audit Committee will be responsible for:
- 1. Reviewing financial reports of the Secretary, Treasurer and any person appointed in a capacity to spend money for club business or functions.
- 2. Conduct Annual audit of receipts and expenditures.
- 3. Present Annual audit results to the Executive Board for their approval.
- 4. Publish results of Annual audit in the newsletter immediately after the Annual meeting.
- 5. ALL records, receipts for expenditures, bank statements, deposit records with detailed explanation of the contents, breakdowns of fundraisers, etc. for the General and Youth accounts should be turned in to the Audit Committee at the Annual Meeting. The Audit Committee will in turn have 60 days until the next scheduled newsletter to complete their findings, list problem areas if any and present to the Executive Board for approval.

Reason for change: This will allow the Audit Committee to audit records that are not ongoing with the current offices so as not to get in the way of the day to day operation of the club.

#### ARTICLE VII. DUTIES OF OFFICERS

Any further payments for dues or fees at any LRBA function will only be accepted in the form of cash, cashier's check or money order.

#### The following were submitted by Mary Beth Bearden

1. The Secretary/Treasurer will serve a term of **three years**. The Board of Directors may remove the Secretary/Treasurer by a majority vote for cause during any term of office.

Reason: More consistant accounting practices over a period of time. If these positions change every year, it will be harder to look back in accounting records over a period of time if the need for such arises.

2. Completely do away with an eboard forum; make a forum for club wide voting. Officers shall present things on this forum that required a vote as they arise.

Reason: all members should have equal say in club business. More votes (instead of two from each club) will give a more rounded impression of the overall thoughts of entire club membership. There may be some directors who are not able to vote on a consistant basis or some that do not want to involve themself on particular issues, costing that club their say on an issue; some directors may abstain from voting due to division in the club over an issue, costing that club their entire say on an issue. True enough there will still be people who do not vote, but certainly there will be more than 2 from each club vote on issues put before the club.

3. Between business meetings, Directors, one appointed by each clubs overall membership decision, shall, **by majority vote**, have the power to approve officer decisions such as hosting shows, expenditures, set budgets and decide on questions of policy brought before them. The sec/treas shall have petty cash fund of \_\_\_\_\_\_ for needed club misc expenses that do not require director approval

Reason: Checks and balance for officer decisions.

4. Any Officer or Director who does not fulfill his/her duties or shows a lack of interest in Club matters, may be asked to resign by a majority vote of the other members of the Board of Directors. The represented club will be notified and shall be asked to replace their vacancy on the board of Directors.

Reason: If directors do not consistantly participate when needed, this allows for replacement.

5. By majority vote of the Board of Directors, the president can be removed from office.

Reason: Provision for the President to be removed for cause if he/she is not fulfilling their duties.

I truly believe that if the LRBA continues to operate with the lack of accountability I have seen, financial disaster is imminent. The lack of record keeping and receipt's kept on expenditures is unacceptable business practices.
