LRBA Annual State Meeting Minutes - June 25, 2011

The annual general membership meeting was called to order at 8:21 AM by President Lynn Hebert. Roll call was done by sign in with 38 adult members signing in. Minutes of last year's meeting were read by Ariana St. Pierre. Yvonne Hebert motioned to accept as published in newsletter with Monna Berryhill seconding the motion and the motion passed. The report of the secretary was read next.

Total membership= 293 Adult membership=176 Youth Membership= 117

10 affiliated clubs and they are: Bonne Terre Rabbit Club, South Louisiana RBA, Central Louisiana RBA, Bayou Holland Lop RC, Louisiana Mini Rex RC, South Mississippi RBA, Magnolia State RBA, Tri Parish Dutch RC, Tiny Town RC. In the 2010-2011 season we had 25 sanctioned youth shows and 24 sanctioned open shows.

Lori Neagle read the treasurer's report and everyone received a copy of the financial report. Yvonne Hebert motioned to accept report as printed and Monna Berryhill seconded the motion. Motion passed. Lori Neagle gave the report of the eboard. Doug Girard motioned to accept report and Shana Neilsen seconded the motion. Motion passed.

There was no Youth Advisory Report. Audit Committee found no discrepancies in financial reports.

Unfinished business:

2012 State Show to be held at the LSU Mini Farm 3/3/2012 Judges are Cheryl Blackman (TX), Allen Mesick (CA), and Julie Ueno(MS). Gwen will get bids on awards. Tabitha Laboyteaux and Nola Vincent will run the concession stand. We still need volunteers to run the raffle table. Our youth activities will be decided and run by our new youth director, Carrie Laboyteaux. A vote was called for to decide on having a banquet after the state show. It was decided to not have a banquet. Blair Guerin volunteered to head publicity for this show.

There was no other old or unfinished business.

New Business: It was brought up to look into new LRBA shirts. Shana Neilsen volunteered for this project. Ariana St. Pierre proposed that LRBA purchase a new, more efficient show program. She volunteered to research the programs. Tyrone Freeman volunteered his expertise in computers to confirm whether the programs were up to par.

CBL Proposals—Proposal one failed by a vote of 30 Against and 4 for.

Proposal 2 failed 30 against and 6 for.

Proposal 3 passed with a vote of 30 for.

The change now reads Article VII Amendments—New amendments or a change in our Constitution or By Laws must be submitted in writing at least sixty (60) days prior to the Annual State Meeting to the LRBA, INC Secretary. Thus he/she must publish said proposals thirty (30) days prior to the Annual State Meeting.

Proposal 4 passed with a vote of 18 for 10 against. This proposal pertains to the youth ambassador program requirements. It now reads, Youth must be a member in good standing for a minimum of one year. Proposals 5 and 10 were voted on together because they were identical. This change passed with a vote of 37 for 1 against. Article X Sweepstakes now reads The LRBA, Inc Sweepstakes and quality points year will run from January 1 to December 31. Discussion followed to decide whether a short year or long year would begin. It was voted on that we would run the first season from June 2011 to December 2012. Proposal 6 passed with a vote of 30 for.

Section 4c now reads:

No more than (2) members or rabbitries from separate households shall be combined. I.e. Siblings may combine regardless of number in family.

Concerning proposals 7 and 10- Lori Neagle moved to keep #7 and "scrap" #11, Monna Berryhill 2nd. A vote was taken and it failed. Lori Neagle moved to keep #11 and "scrap" #7. Yvonne Hebert 2nd the motion. A vote was taken and this motion passed. A vote was taken on Proposal 11 and it did not pass.

Proposal 8—Awards Criteria passed with 29 for. The change now instilled says the recipient of the rookie of the year award shall be an active member of the LRBA, Inc for less than two (2) years at time of nominations.

Proposal 9-Article XI Annual State Show

Section 3 passed with a vote of 31 for. It now reads: The LRBA, Inc will furnish the awards for Best in Show, 1st Runner Up to Best in Show, 2nd runner up to Best in Show, and Best Opposite Sex in Show. Awards for Best of Breed and Best Opposite Sex of Breed will be furnished by LRBA, Inc and be awarded for all ARBA, Inc recognized breeds.

The annual state show for 2013 was discussed and the sites submitted were the American Legion in Bogalusa, La and a facility in Rapides Parish. There were no volunteers for Show Superintendent or Show Secretary. Judges suggested were Mary Crawford, Sheri Abrahamson, Cheryl Blackman, Don Mersiovsky, Eric Stewart, Chris Hayhow, Tanner Biggs, Wade Burkhalter and the lineup of judges from Memorial Weekend 2011.

Southern University Show was discussed. Doug Girard moved that we maintain our relationship with Southern in regards to the rabbit show and be prepared for 2012. This motion passed 19 for and 17 against. Show Superintendent is Doug Girard, Show Secretary is Shana Neilsen, and Concessions will be run by Yvonne Hebert. Suggested judges were Cheryl Blackman, Frank Farrow, Mary Jo Terry, Ted Deloyola, Michael Franke, and Tony Bell.

Memorial Weekend Show 2012 was discussed. Proposed show sites were to check on the Rapides Coliseum and possibly return to facility in Church Point. Show Superintendent is Lance Gendron. Show secretaries will be Shana Neilsen-Open and Ariana St. Pierre- youth. Angela Cavalier moved to have eboard check the sites. Motion passed. Collette Waters volunteered for concessions. Shana Neilsen volunteered to research and handle awards. Lance Gendron motioned for a \$2000 budget for awards. Angela Cavalier 2nd the motion and it passed. Lance Gendron motioned for a budget of \$5500 for judges due to the need for increasing the number of judges. Yvonne 2nd the motion. Motion failed. Angela Cavalier motioned for a budget of \$4500. Collette moved to amend motion to \$5000, 2nd by Angela Cavalier. Motion passed.

State show 2012-BIS travel trophies are completely filled in and need new plaques. Three local clubs have been approved for specialty shows at state show. BHLRC, LMRRC, and TPDC

An election of officers was held. Kevin LeBlanc was nominated for President. No other nominations were submitted and Kevin was elected. Yvonne Hebert was nominated for Vice President. No other nominations received and Yvonne was elected. Ariana St. Pierre was nominated for Secretary and no other nominations were received. Ariana was elected. Amy Lukaszeski was nominated for treasurer. No other nominations received and Amy was elected. Carrie Laboyteaux was nominated for Youth Director. No other nominations received and Carrie was elected.

Sweepstakes awards were announced and certificates handed out.

Yvonne motioned to adjourn the meeting, 2nd by Blair Guerin.

Open Breeder of the Year- Collette and Glenn Waters, Buster Charpentier, Tracey and Tyrone Freeman, Lynn Langley



Show Room Etiquette by Collette Waters

I've been listening to people talk all season about their experiences at shows. The experience has run the gauntlet from most horrid to wonderful but one recurring complaint has been "rude" behavior. Often times the behavior in question was the result of a person just not knowing what was the expected behavior. Based on these comments I have compiled twelve basic rules for the polite exhibitor.

1. Arrive early, especially if you have day of show entries or several changes to your entry. The show can't start till the secretary makes the changes and adds the late entries.

2. Check your entries and keep a copy of your changes. Ear tag numbers cannot be changed and rabbits cannot be added once judging starts. If there is a conflict (scribal error) at the judging table it can be easily solved if you have a copy of your entry form showing the changes/entries. Please understand that if the show secretary does not have a copy of your entry/change the show superintendent cannot change what is on the control sheets (I like NCR entry forms!)

3. Look around – if the show room is getting crowded consolidate. Stack carriers, fold up chairs that aren't being used, put away the grooming table, stack or tuck ice chests.

4. When setting up camp try to set up in rows to allow easy movement from back to front of showroom. It is no fun to try and navigate a maze toting 90 lbs of rabbits not to mention tripping over a carrier or chair stuck out in the aisle.

5. If possible, set up no closer than ten feet from the judging tables to allow room for exhibitors to stage their rabbits and get them to the table in a timely manner.

6. Listen for your breed being called! In a perfect world a PA system would be available but that is often not the case.

7. Please let the judge work without interruptions. Listen to the judge's comments –that's what you paid your entry fee for. If you have a question wait till he/she finish with the breed. Most judges are delighted to answer questions between breeds.


8. Be patient, breeds are judged in order of number entered. It is suggested that giant breeds and running breeds are judged first while the judge is fresh. (You try handling a cranky 18 pound Flemish after you been picking up rabbits for eight hours or chasing a Checkered Giant that has been cooped all day.)

9. Offer to help write, run folders, add entries at registration, set up or break down or any of the other tasks that make a show run smoothly.

10. Display good sportsmanship – both when winning and when losing.

11. Clean up your area when you leave.

12. Have fun! Remember showing rabbits is a hobby.
