THE FOLLOWING ARE PROPOSED CHANGES TO THE CBL. THESE ARE TO BE VOTED ON AT THE STATE MEETING IN JUNE:

CURRENT VERSION:

ARTICLE III. MEMBERSHIP & PRIVILEGES

Section 1. Membership fees in LRBA, Inc. to be as follows:

Adult \$12 per year, \$30 for three years;

Youth (through the age of 18) \$8.00 per year, \$20.00 for three years;

Combination (two adults-same address) \$20.00 per year, \$50.00 per three years;

Family (one or two adults- same address) \$16.00 + \$2.00 per year per youth; \$45.00 (one or two adults-same address) + \$5.00 per youth for three years.

Section 2. Failure to renew individual, youth, or any combination membership within thirty (30) days following the expiration date shall result in automatic termination of membership.

Section 3. Any LRBA, Inc. member may pay a fee of one dollar (\$1.00) per annum to register his/her rabbitry with the LRBA, Inc.

Section 4. Any LRBA, Inc. member may pay a fee of one hundred dollars (\$100.00) for a lifetime membership.

Section 5. Youth members are entitled to vote and hold elected office in Youth Division only.

PROPOSED VERSION:

ARTICLE III. MEMBERSHIP & PRIVILEGES

Section 1. Membership fees in LRBA, Inc. to be as follows:

Adult \$12 per year, \$30 for three years;

Youth (through the age of 18) \$8.00 per year, \$20.00 for three years;

Combination (two adults-same address) \$20.00 per year, \$50.00 per three years;

Family(one or two adults- same address) \$16.00 + \$2.00 per year per youth; \$45.00 (one or two adults-same address) + \$5.00 per youth for three years.

Section 2. Failure to renew individual, youth, or any combination membership within thirty (30) days following the expiration date shall result in automatic termination of membership.

Section 3. Any LRBA, Inc. member may pay a fee of one dollar (\$1.00) per annum to register his/her rabbitry with the LRBA, Inc.

Section 4. Any LRBA, Inc. member may pay a fee of one hundred dollars (\$100.00) for a lifetime membership.

Section 5. Youth members of thirteen (13) years of age, and above are allowed to vote in the General Meeting of the LRBA Inc. Youth members below the age of thirteen (13), have the right to vote in the youth division only.

Reasoning:

There are several youth members that help the LRBA put on a show, by volunteering their time, writing, working the raffle table, and helping the show committee do day of show entries. As by helping, the youth should have a say on who governs our club, what Proposals that ultimately affect they youth.

2nd PROPOSED VERSION:

ARTICLE III. MEMBERSHIP & PRIVILEGES

Section 1. Membership fees in LRBA, Inc. to be as follows:

Adult \$12 per year, \$30 for three years;

Youth (through the age of 18) \$8.00 per year, \$20.00 for three years;

Combination (two adults-same address) \$20.00 per year, \$50.00 per three years;

Family (one or two adults- same address) \$16.00 + \$2.00 per year per youth; \$45.00 (one or two adults-same address) + \$5.00 per youth for three years.

Section 2. Failure to renew individual, youth, or any combination membership within thirty (30) days following the expiration date shall result in automatic termination of membership.

Section 3. Any LRBA, Inc. member may pay a fee of one dollar (\$1.00) per annum to register his/her rabbitry with the LRBA, Inc.

Section 4. Any LRBA, Inc. member may pay a fee of one hundred dollars (\$100.00) for a lifetime membership.

Section 5. Youth members of thirteen (13) years of age, and above are allowed to vote in the General Meeting of the LRBA Inc. Youth members below the age of thirteen (13), have the right to vote in the youth division only.

PROPOSED CHANGED #2

Current Version:

Section 4. Annual Youth Scholarship Show

A. The Annual Youth Scholarship Show is to be held on a date to be determined by the LRBA Youth Advisory Board. The Youth Division is responsible for the operation of this show.

B. The prior year's Louisiana Youth Rabbit Senior Ambassadors are to be designated as Show Superintendent and Show Secretary for this show.

C. Proceeds from this show are to be dedicated to the Youth Scholarship Fund.

Proposed Version:

Section 4. Annual Youth Scholarship Show

A. The Annual Youth Scholarship Show is to be held on a date to be determined by the LRBA Youth Advisory Board. The Youth Division is responsible for the operation of this show.

B. The Youth Show is to be run by the youth officers, along with help from the Open Officers. The Youth President and Vice President shall Co- Superintendent the show with the Open President. The Youth Secretary, and Treasure shall Co- Secretary the show with the Open Secretary.

C. Proceeds from this show are to be dedicated to the Youth Scholarship Fund.

Reasoning:

The Youth Show is supposed to be run by the Youth, this amendment enables the Youth to have an active lead in the show, without over stepping boundaries that could affect the club, or youth Fund. This also allows Youth to be able to learn and follow examples that the Open set. The Youth officers are actually voted in by their peers, this enables them to represent the Youth in the youth Show.

Article 3 Membership Privilege

Section 5. Youth members are entitled to vote and hold elected office in Youth Division only.

Change to: Youth age 13 and older may sit in on and VOTE on all adult business.

Our youth pay at age 12 adult rate for movies, meals, etc. I think it fair and necessary that our older youth have an active vote on adult issues - if they wait until they are 19 to sit in on meeting of what good

is that doing for them - they should be learning NOW how the adult meetings work and have an active part in it so they are ready at age 19 to step up and do some things at the adult level......I recommend age 13 and older as that is the age division for senior ambassadors.

Article X Sweepstakes

Section 3, Sections B, C, D:

- B. Exhibit his/her breed(s) at the Annual State Show, except newly acquired breeds.
- C. Open show only- Exhibit his/her breed(s) at the Annual State Show plus one of the all breed LRBA sanctioned shows held during the sweepstakes year.
- D. Youth Show Only- Exhibit his/her breed(s) at the LRBA Annual State Show and the LRBA Youth Scholarship Show. If extenuating circumstances arise that a youth cannot attend one of the two required shows, then he/she shall turn written proof of absence over to the Executive Board of the LRBA, Inc. postmarked within thirty (30) days of the show. The Executive Board has sixty (60) days after the show (Annual or Scholarship) to approve/disapprove any excuses received and notify the member and sweepstakes chairperson of eligibility for the sweepstakes.

I propose these THREE ABOVE NOTED be expunged from our CBL entirely. Regarding everyone: due to the economy, it is not possible for us to attend all shows. And regarding YOUTH, how can they get to shows if their parent(s) or other responsible party does not bring them. Not all youth live near other breeders for a car ride and not all parents will allow their child to go off with other people (cars break down, houses burn, people die, people get married, people give birth, parents have surgery, etc.) And PARENTS choose what their kids do and where they go - especially not fair to the youth. In addition if something happens to

someone in the family OTHER than the youth, this rule does not seem to apply so much (i.e. another child sick in family or a parent has surgery so that no one in family can travel, then youth is not exempted as it is not the youth that is sick or had surgery). I think these above rules unrealistic and unfair.

I do suggest that double points still apply for these two shows - for those that are seriously interested in sweeps, they will come if at all possible and should get the gravy for doing so.

ARTICLE X. SWEEPSTAKES section 1:

Section 1. The LRBA, Inc. sweepstakes and quality point year will run January 1 through December 31 of each year. The LRBA, Inc. will sponsor one open and one youth sweepstakes and quality points contest per year. All open points to be accumulated from open shows. All youth points to be accumulated from youth shows. These two shall not be combined and awards shall be given separately for each sweepstakes and quality points contest.

Recommend an addition to this: Youth may gain YOUTH sweeps points in OPEN shows where there is no youth show. Example two open and one youth show with youth showing in the youth show and the second open show - youth should receive sweeps points for both shows towards YOUTH sweeps even though one is an open show. ARBA rules allow them show in open shows when this occurs and they are paying the entry fees and supporting the show; therefore they should get any points earned in an open show under these circumstances applied to their youth sweeps.

Section 4 Annual Youth Scholarship show Section B:

B. The prior year's Louisiana Youth Rabbit Senior Ambassadors are to be designated as Show Superintendent and Show Secretary for this show. I recommend this include the following: unless there are no senior ambassadors, then the junior ambassadors co-run the show along with an adult appointed superintendent and secretary.

ARTICLE IV. ELECTION

Section 1.

Officers shall be nominated and elected at the Annual State Meeting. The term of office is to run from close of Annual State Meeting to close of Annual State Meeting.

I recommend this be added: No officer shall hold any office or combination of offices for longer than 4 years unless there are no other nominees. This will prevent people from being overtaxed/tired/weary and will allow for new ideas to promote growth of our clubs.

PROPOSED CHANGE:

Article IV Elections: Section 1:

ARTICLE IV. ELECTION

Section 1. Officers shall be nominated and elected at the Annual State Meeting. The term of office is to run from close of Annual State Meeting to close of Annual State Meeting.

Propose to add that any person nominated or seeking to be nominated is required to be present at State Meeting.

PROPOSED CHANGE:

Currently reads:

BY-LAWS - Article X. Sweepstakes.

Section 3. To qualify for sweepstakes and quality points, the exhibitor (I.e. Individual, partnership, or combined rabbitry) must:

A. Be a member of the LRBA, Inc. at the time of or join during the Annual State Show

and must renew within thirty (30) days of expiration.

B. Exhibit his/her breed(s) at the Annual State Show, except newly acquired breeds.

C. Open show only - Exhibit his/her breed(s) at the Annual State Show plus one of the all breed LRBA sanctioned shows held during the sweepstakes year.

D. Youth Show Only - Exhibit his/her breed(s) at the LRBA Annual State Show and the LRBA Youth Scholarship Show. If extenuating circumstances arise that a youth cannot attend one of the two required shows, then he/she shall turn in written proof of absence over to the Executive Board of the LRBA, Inc. postmarked within thirty (30) days of the show. The Executive Board has sixty (60) days after the show (Annual or Scholarship) to approve/disapprove any excuses received and notify the member and sweepstakes chairperson of eligibility for the sweepstakes

Proposed change #1:

Section 3. To qualify for sweepstakes and quality points, the exhibitor (I.e. Individual, partnership or combined rabbitry) must be a member of LRBA, Inc. And renew membership within thirty (30) days of expiration. If membership is allowed to expire more than 30 days, points will be relinquished.

Reason: The incentive of double points at both the state and youth shows should be enough incentive for those wishing to win points to attend. If you keep your membership current, you should keep your points.

Proposed change #2:

Section 3. To qualify for sweepstakes and quality points, the exhibitor (I.e. Individual, partnership, or combined rabbitry) must:

A. Be a member of LRBA, Inc. and renew membership within thirty (30) days of expiration. If membership is allowed to expire more than 30 days, points will be relinquished.

B. Exhibit his/her breed(s) in at least two LRBA, Inc. sanctioned all breed events held on different days during the sweepstakes year.

Reason: The incentive of double points at both the state and youth shows should be enough incentive for those wishing to win points to attend. If you keep your membership current, you should keep your points. This option does allow for some required attendance at LRBA sanctioned all breed events which gives them the option of maybe picking a shows closer to home.

In the event that the above or similar passes the following should be in place.

By Laws - Article X, Sweepstakes

Section 7. If extenuating circumstances arise that an exhibitor cannot attend the LRBA, Inc. Annual State Show and provided that the exhibitor is an LRBA, Inc. member in good standing prior to the time of the LRBA, Inc. State Show and he/she feels the reason is valid, then he/she shall turn written proof of absence over to the Executive Board of the LRBA, Inc. postmarked within thirty (30) days of the Annual State Show. The Executive Board has sixty (60) days after the Annual State Show to approve/disapprove any excuses received and notify the member and sweepstakes chairman of eligibility for the sweepstakes.

Proposed change: Eliminate Section 7

Constitution - Article IV. Membership

Section 3. All individuals shall have the right to vote in their respective divisions at the Annual State Meeting. Individual members may not vote by proxy. No individual member may have more than one vote.

Reason: Eliminate in person. A paying member should have the right to vote on officers whether they are able to attend or not. Especially due to work or illness. They should be able to send in a handwritten/signed ballot.

PROPOSED CHANGE:

Abolish all mandatory show attendance to qualify for the LRBA sweepstakes and quality points program.

Article X, Sections 3 C (Open) and D (Youth).

Reason:

The double points awarded for the Annual State Show and Youth Scholarship Show in an incentive in itself for someone to attend who wants the sweepstakes points. Making it mandatory for youth that have to rely on someone else to get them there or their rabbits can create hardships to some

families. Everyone does not have a 9 to 5 job, 5 days a week.

The national clubs do not make it mandatory to attend convention or nationals for sweepstakes. Why does LRBA?

By being a member of LRBA, sweepstakes is a membership privilege. If not, why be a member of LRBA?

As stated in By-Laws

ARTICLE X. SWEEPSTAKES

Section 3. To qualify for sweepstakes and quality points, the exhibitor (i.e. individual, partnership, or combined rabbitry) must:

- A. Be a member of the LRBA, Inc. at the time of or join during the Annual State Show and must renew within thirty (30) days of expiration.
- B. Exhibit his/her breed(s) at the Annual State Show, except newly acquired breeds.
- C. Open show only- Exhibit his/her breed(s) at the Annual State Show plus one of the all breed LRBA sanctioned shows held during the sweepstakes year.
- D. Youth Show Only- Exhibit his/her breed(s) at the LRBA Annual State Show and the LRBA Youth Scholarship Show. If extenuating circumstances arise that a youth cannot attend one of the two required shows, then he/she shall turn written proof of absence over to the Executive Board of the LRBA, Inc. postmarked within thirty (30) days of the show. The Executive Board has sixty(60) days after the show (Annual or Scholarship) to approve/disapprove any excuses received and notify the member and sweepstakes chairperson of eligibility for the sweepstakes.

Change in By-Laws

ARTICLE X. SWEEPSTAKES

Section 3. To qualify for sweepstakes and quality points, the exhibitor (i.e. individual, partnership, or combined rabbitry) must:

- A. Be a member of the LRBA, Inc. at the time of any LRBA sanction show and must renew within thirty (30) days of expiration.
- B. Exhibit his/her breed(s) at any LRBA sanction show.
- C. Open Exhibit his/her breed(s) at any LRBA sanction show during the sweepstakes year. Double points shall be awarded to any exhibitor that participates with his/her breed at the LRBA State Show.
- D. Youth- Exhibit his/her breed(s) at any LRBA sanction show during the sweepstakes year. Double points shall be awarded to any exhibitor that participates with his/her breed at the LRBA State Show and / or the LRBA Youth Scholarship Show.

PROPOSED CHANGE:

The Executive Board has sixty (60) days after the show (Annual or Scholarship) to approve/disapprove any excuses received and notify the member and sweepstakes chairperson of eligibility for the sweepstakes

Section 3. To qualify for sweepstakes and quality points, the exhibitor (I.e. Individual, partnership or combined rabbitry) must be a member of LRBA, Inc. And renew membership within thirty (30) days of expiration. If membership is allowed to expire more than 30 days, points will be relinquished.

Reason: The incentive of double points at both the state and youth shows should be

enough incentive for those wishing to win points to attend. If you keep your membership current, you should keep your points.
